Families registered at St. Anthony Parish may apply for a St. Anthony Stewardship Scholarship. Below is the Parish Stewardship Scholarship Eligibility Policy:

1. At least one parent must be a baptized and currently practicing Catholic who lives according to the Precepts on the Roman Catholic Church. Please see below.
2. The family or the Catholic parent must be registered in the parish and practicing stewardship for a period of 6 months before becoming eligible for this sizable monetary benefit.
3. The child(ren) attending St. Anthony School must be:
 - Baptized Catholics. If not, the scholarship eligibility begins six months after they are baptized and become practicing members of the faith.
 - Practicing the appropriate Precepts of the Church, especially number one: participation at Sunday Mass.
 - Parent(s) must apply for the scholarship each year and agree to meet or exceed the **three minimum stewardship requirements** set forth below:
 - i. Annually complete and turn in the Parish's Annual Stewardship Intention Card in October.
 - ii. Attend Mass at St. Anthony at least 26 weekends a year. Attendance is counted by dropping your pre-printed envelope in the collection basket. If you contribute monthly just drop in an empty envelope. If you forget your pre-printed envelope just take a small piece of paper and write your family's name and address on it and drop it in the collection basket.
 - iii. Volunteer a minimum of 24 hours of time and talent each year. Failure to meet these 3 items will result in the elimination of the scholarship.

The Precepts of the Church

The Catholic Church has long established these items to be the minimum requirements for one to be considered a practicing Catholic:

- 1) To participate in Mass each Sunday and on holy days of obligation.
- 2) To fast and abstain on days designated by the Church.
- 3) To confess one's sins at least once a year.
- 4) To receive Holy Communion during Easter time.
- 5) To contribute to the support of the Church.
- 6) To observe the laws of the Church concerning marriage.
- 7) To join in the missionary spirit and apostolate of the Church.

The Catechism of the Catholic Church lists 5 precepts (Paragraph #2041). The last two are included elsewhere in the catechism and are equally important.

Parish Families in 2017-18 are eligible for the following Scholarship amounts:

- 1 Child - \$1,300
- 2 Children - \$3,100
- 3 Children - \$4,900
- 4 Children - \$6,700

Families with children in school during the 2010-11 school year have been grandfathered in the multiple student scholarship levels that were in place at that time.
